For many years the AGBI produced an Annual Report including the trustees' report, the auditors' report, commentary on the main achievements and challenges the AGBI faced, the audited accounts and financial summary. The feedback we received from our major stakeholders, stewards and donors was that this format was wordy and the main points regarding our grant giving programme were hard to find.

Therefore, this year we have produced an Impact Report to highlight our main achievements and information on our stewards and donors.

We continually strive to make the AGBI as relevant and efficient as it can possibly be and with the help of our stewards (who fundraise and identify potential applicants) we will continue to help artists in need in the years to come.


Who we are

The Artists' General Benevolent Institution (AGBI) was founded by J.M.W Turner in 1814 and incorporated by Royal Charter in 1842, it is one of the oldest charities in the United Kingdom.

The AGBI financially supports professional artists in need and their dependents living in England, Wales or Northern Ireland who cannot work or earn due to accident, illness or older age.

The AGBI is run by a Council of mainly practicing artists, sculptors, designers, architects, medical professionals and craft workers who give their time freely and meet regularly to discuss cases.

The Council is supported by a small team of staff based at Burlington House, Piccadilly, London.



Who we help

Who does the AGBI help?

Any professional artist, painter, sculptor, illustrator or art teacher at A-level or above can apply for help if they have earned their living (or major part of it) from art and cannot work or earn due to accident, illness or older age.

Widows and orphaned children of artists are also eligible for help.

Unfortunately, the AGBI cannot assist in cases where recession has caused career difficulties or when an artist is unable to find a market for their work. The AGBI cannot assist with legal fees, business difficulties or education grants for mature students.



The AGBI Council look at the training, qualifications, art-CV detailing shows and exhibitions, employment and the number of years applicants have made a living from art. The AGBI Council will also need to see original examples of an applicant's work.

How we help

Assistance is given in the form of a grant for a period of one year. Sometimes this is all that is needed but generally the help is longer term. For those long term cases the circumstances are reviewed annually by the AGBI Council who meet regularly and decide the level of financial help an applicant needs for the coming year.

All matters concerning applicants names and details of help given is kept strictly confidential.

During 2015 – 2016 we ceased to help nine applicants, seven of whom no longer needed or were no longer eligible for support and very sadly two applicants passed away.

Case studies

The AGBI supports artists who are in difficult circumstances medically and financially. When an artist's life, career and health start to collapse the AGBI is often the only benevolent fund to which they can turn.

The support we give is person-centred, meaning we do our best to help our applicants in the most appropriate and meaningful way.

In March 2016, a referral came in from one of our stewards for a sculptor in his late 80s who has dementia. His dementia was diagnosed several years ago and his family were doing all they could to keep him at home.

As his dementia progressed it became obvious that the family did not have the skills or capacity to look after all his needs.

The house had a very basic bath and shower that the sculptor was not able to use safely and the provision of care that the State was providing was simply not sufficient. The sculptor and the family needed additional support. The AGBI agreed to fund a new step free shower and to provide additional night-time care to support the applicant and give the family some well needed respite.

Case studies

The Motor Neurone Disease Association contacted the AGBI about a painter living in Cornwall who needed support.

The painter had been a distinguished artist since the 1960s juggling a career as a painter, an art teacher and raising her young family in her early years and then maintaining a studio and practice in her later years.

Her condition had meant that she was no longer able to paint – which was heart breaking for the artist – and therefore no longer able to go to her studio. She had struggled financially for many years and had fallen into debt.

During her assessment it was clear that financial support for the very basic items was necessary. The AGBI was able to provide funding to pay for her gas and electricity bills, to buy much needed clothing and bedding and to provide a new washing machine to make her life that little bit easier.

Case studies

The grant was an enormous help... but the feeling of an artistic community, support and practical help and believing in me was key to my recovery.

I am sitting here in my studio with all my paints and brushes around me and I just want to thank the AGBI for the support. Thank you so much for your generous support. As an artist with a disability your support will transform my practice as a painter.

Your grants are a life-line and help me cope with unforeseen expenses and general day to day costs. I would be lost without them.






Our Christmas card sales
